Pursuant to Chapter VI, Section 2 of the Rules and Regulations of the Board of Fire and Police Commissioners Commissioners. the Board issues a call for Examination for the position of Firefighter/Paramedic under the following criteria:

- The orientation and written examinations will take place on April 9, 2022 at Oakton Community College in Des Plaines Illinois.
- The candidates will be required to pay an application fee of \$35.00.
- Applicants may contact I.O. Solutions with questions per the application instructions document.
- The Situational Judgement Test shall be a subjective evaluation component of the process which is designed to evaluate how the applicant would respond to various situations and measure conflict resolution skills, service orientation, initiative, integrity, team orientation, and other traits. (Rules and Regulations Section 2, bullet point 4 and Section 4(b))
- The minimum passing score to the written examination shall be 70%. (Rules and Regulations Section 2,
- Open positions will be filled from the resulting eligibility list as Firefighter/Paramedic.

Discussion pertaining to the recruitment statistics from the previous Probationary Firefighter/Paramedic eligibility list. Fire Chief Anderson stated 45 candidates were on the list. Eight were hired, however, one resigned before their start date to work in Aurora and one could not finish the academy. Six remain employed with the City of Des Plaines Fire Department and completed their probation. Those that withdrew found firefighter/paramedic positions elsewhere.

# 1. Discussion regarding Police hire statistics

Officer Bjork reviewed the recruitment statistics from pervious Probationary Patrol Officer eligibility lists. Officer Bjork stated that many withdraws occurred due to timing and other departments making offers of employment before the City got to them on the list. This is outside the Commission's control. The previous list resulted in 84 short forms, which is consistent with surrounding department eligibility list statistics.

Police Chief Anderson thanked Officer Bjork for his work on this information. The statistics are consistent with area Police Departments.

Commissioner Albrecht requested that the Board have materials to discuss the Lateral Patrol Officer process at the next regular meeting of the Board. Police Chief Anderson agreed.
