#### **New Business:**

1. Review and Approval of May 11, 2023 Special Meeting Minutes

Chairman Albrecht brought up that there was previous discussion of bringing down the required test score to 70% for police, and asked whether that would be on the agenda soon. Police Chief Anderson stated that there was cleanup being done with the rules and regulations by the City Attorney, which would be brought to the BFPC when ready for review. He noted that the recommendation for testing is that it should not be based on a percentage, rather passing scores should be based on vendor recommendations. The rules would state the passing percentage would be determined by the BFPC based on the testing vendor's recommendations for each test. As an example, Police Chief Anderson noted that NTN (the current vendor) has a test to determine a candidate's potential bias, and according to the vendor a good score, a passing score, is about 60% because it is a difficult test. Currently, that portion of the test is Pass/Fail for DPPD candidates so it did not affect the weighted score. The passing percentage is determined by the vendor looking at results from hundreds of tests they administer across the country, as noted by Police Chief Anderson.

In terms of current openings for police, there are roughly 7 at this time according to Deputy Chief Shanahan. Police Chief Anderson stated one declined an offer, one accepted, and another is starting in October.

Therefore, in conversations with other Chiefs, he has noticed that there are a lot of short forms for them as well. It's not outside of the current norm. Commander Rice noted that there were two new lateral candidates that just came in and were being reviewed. Chairman Albrecht then asked how Kentech, who is performing background checks for Fire candidates, was going. Fire Chief Anderson stated it has been working well so far, and they anticipate having all backgrounds done by July 31<sup>st</sup>, so there can be interviews starting in the first or second week of August.
