HR Director Madison noted that, due to vendor scheduling, it is unlikely that candidates who passed the conditional testing will be approved in time before the April Academy. She did note that Dylan Lersch has accepted and is going to testing next week. Candidate Lersch was the only candidate from the previous set of interviews who was passed and already has a paramedics license. Fire Chief Anderson noted that additional hiring will depend on when candidates get their license, and it will follow list order. Chairman Albrecht inquired about whether the three candidates who were passed (Lersch, Elliott, Schelin) will have to go through the Academy. Fire Chief Anderson replied this will depend on the results of evaluating their skills after they start. He also noted that three hires would bring the department up to staff today, but they would like to hire five (5) in anticipation of additional retirements in May.
