2. Approval of the 2024 Sergeants Promotional Eligibility Register.

Police Commander Matt Bowler provided an overview of the 2024 Sergeants Promotional Process. Confirmed that 25 candidates applied for the process and nine (9) candidates made it on to the final list. Chairman Albrecht asked how this promotional list compares to prior lists. Deputy Chief Sean Flanagan stated that the last list was approximately 20, which has historically been the number of candidates on the list.

Chairman Albrecht asked the longevity of each candidate. Deputy Chief Shanahan confirmed that longevity ranges from six (6) to approximately 20 years. Finally, Police Chief Anderson provided a brief

overview on the award of Chief's Points. The minimum number to be provided to a candidate was 17 and the maximum number was 22. The Chief stated that it did adjust the list somewhat but had a minimal impact overall.

HR Director Madison confirmed that the approved list will be posted in City Hall and on the City's website.
