2. Discussion pertaining to the Commissions preferred psychological assessment vendor.

Human Resources Director Becky Madison provided a brief overview of the selection and retention of the BFPC's current psychological assessment provider, C.O.P.S. & F.I.R.E., as well as their status and performance as the selected vendor. The purpose of the discussion was to brief the Commissioners on the vendors' request to sign an updated terms of service agreement providing an overview of late fees and rush processing, which was not provided for in the current service agreement.

Director Madison provided a detailed overview of the vendors' performance and applauded their ability to schedule appointments and make accommodations. However, with the updated terms, the vendor is



unable to hold appointment times for the Commission due to the cancellation fees the City would experience. Additionally, Director Madison communicated that since her participation with the Commission began in 2021, the vendor has recommended and passed every candidate, approximately 48 evaluations, which is uncommon. Given that the vendor is in the final year of their original agreement, Director Madison requested the Commission's permission to review and evaluate alternative vendors for their consideration. The Commission agreed to this request.

Chairman Albrecht requested staff survey area communities to obtain a benchmark on psychological examination failure rates, as well as determine appropriate alternative vendors. The Commission determined it was appropriate to include the current vendor to provide an explanation to their change in practices and the impact it has on their current clients.

Director Madison agreed to coordinate the vendor review and provide an update by the end of the year.

3. Discussion regarding the selection of a date for entry level patrol officer interviews.

To prepare for entry level patrol officer interviews, Director Madison requested the Commission consider additional summer meeting dates for processing and interviewing candidates. The Commission agreed to meet at Noon, July 10<sup>th</sup> if needed. They also agreed to host interviews on July 29<sup>th</sup> and 31<sup>st</sup> from Noon to 5:00 p.m. in the Second Floor Conference Room.
