
2. Review and approval of the Special Meeting Minutes of July 31, 2024.

3. Discussion and approval of a Call for Examinations to fill the vacant position of probationary Firefighter/Paramedic.

Chairman Albrecht asked about the "candidates are not required to pay" portion of the call. Chief Matzl confirmed that this is indeed language used previously. Human Resources Director Becky Madison noted that the City does help candidates with a hardship by providing a fee waiver, they just need to ask for it. There is a \$55 fee to test with the National Testing Network and a \$15 fee to apply their score to a specific department, and that fee can be waived if requested by the candidate due to hardship.

Regarding preference points, Chief Matzl noted that candidates have a potential for a minimum of 10 points and a maximum of 30 per State of Illinois Statute. The City is compliant by offering up to 25 preference points. Chairman Albrecht asked that it be reworded to better reflect what was just explained. HR Director Madison stated it will be adjusted. She explained that the range of preference points a Des Plaines candidate can qualify for is 0 to 25. If the person qualified for everything, they would get 25 points. They only get what they qualify for. Per State Statute, you must allow for at least 10 preference points, but no more than 30. The City is noting in this document that their max preference points for this test is 25.

Through his motion Commissioner Green read into the minutes the following items to satisfy Chapter IV, Section 2:

- Examinations will be conducted and proctored remotely as scheduled by the candidate with NTN during the application period.
- The candidates will NOT be required to pay an application fee directly to the City of Des Plaines but to NTN.
- Applicants may contact NTN with questions per the application instructions.
- The Situational Judgement Test shall be a subjective evaluation component of the process.
- The position to be filled from the resulting eligibility list is Firefighter/Paramedic.

My motion also allows for the formal appointment of Candidate Lombardo by the BFPC Chairperson without the need for the BFPC to reconvene if Candidate Lombardo successfully passes the psychological, medical and drug/alcohol exams and/or tests. My motion however precludes Candidate Lombardo's appointment if by chance he fails one or more of the aforementioned exams/tests and/or if one or more BFPC Members call for further discussion about Candidate Lombardo's appointment with that call occurring within 3 calendar days of having received the exam/test results from Human Resources.
